Motion made by Alderman Concannon and seconded by Alderman Mercer-Bruen to return to the regular order of business, all in favor, 5-0.

**Renewal of First Class Motor Vehicle Sales License by Woburn Foreign Motors, Inc.:**

Alderman Mercer-Bruen asked if there have been any problems. Chairman Higgins said there have been no problems. Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell that the license renewal “ought to pass,” approved, 5-0.

**Renewal of Second Class Motor Vehicle Sales License by ACT Leasing Inc.:**

Alderman Mercer-Bruen recused herself. Chairman Higgins acknowledged Alderman Mercer-Bruen’s recusal. Chairman Higgins said the following conditions have been imposed on the license: 1. That no more than 30 vehicles may be kept on-site at any one time; 2. That the vehicles shall be kept on the Wood Street side of the lot in the 16 spaces abutting Wood Street; the nine spaces abutting Salem Street and the last five spaces shall be in the aisle across from the 16 spaces closest to Salem Street; and 3. That the holder of this license may sell or exchange used vehicles solely on a wholesale basis. Motion made by Alderman Campbell and seconded by Alderman Concannon that the license renewal “ought to pass;” approved, 4-0.

**Renewal of Second Class Motor Vehicle Sales License by Anchor Auto Sales, Inc.:**

Alderman Mercer-Bruen recused herself. Chairman Higgins acknowledged Alderman Mercer-Bruen’s recusal. Alderman Gately asked if there are any problems. Chairman Higgins said there is nothing in the file. Motion made by Alderman Gately and seconded by Alderman Campbell that the license renewal “ought to pass;” approved, 4-0.

**Renewal of Second Class Motor Vehicle Sales License by Michael R. Celata dba Central Automotive:**

Chairman Higgins said there is a limit of three vehicles and eight conditions. Alderman Gately asked if there have been any more problems. Chairman Higgins said she has not received anything. Chairman Higgins noted there is a special permit associated with the business. Motion made by Alderman Gately and seconded by Alderman Concannon that the license renewal “ought to pass;” approved, 5-0. Alderman Mercer-Bruen said she has not received any calls about problems at the business.

**Renewal of Second Class Motor Vehicle Sales License by E&C Auto Brokers, LLC:**

Chairman Higgins said there is a limit of five vehicles and a condition that vegetation on the property must be maintained. Alderman Gately said the proprietor has cleared the corner.

President Anderson has said there have been no complaints. Alderman Concannon asked if this is the site of Carbone's old gas station. President Anderson said it is. Alderman Concannon said there are lot of vehicles on the site but that not all of them might not belong to the licensee. Motion made by Alderman Campbell and seconded by Alderman Gately that the license renewal "ought to pass;" approved, 5-0.

**Renewal of Second Class Motor Vehicle Sales License by Nicolas Saba dba Montvale**

**Service:** Chairman Higgins said there is a limit of 12 vehicles. Alderman Campbell asked if there have been any problems. Chairman Higgins said there is nothing in the file. Motion made by Alderman Campbell and seconded by Alderman Concannon that the license renewal "ought to pass;" approved, 5-0.

**Renewal of Livery License by Kelley Towncar, Inc.:** Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell that the license renewal "ought to pass;" approved, 5-0.

**Motion made to adjourn by Alderman Concannon and seconded by Alderman Mercer-Bruen;** approved, 5-0. Chairman Higgins adjourned the meeting at 6:18 p.m.
