First Class Motor Vehicle Sales License renewals: Woburn Foreign Motors, Inc.: Alderman Mercer-Bruen asked if there was anything in the jacket that might hold up the renewal. Alderman Higgins said all the paperwork is in order. Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell that the license renewal “ought to pass;” with any existing conditions and limitations; approved, 5-0; **Lannan Chevrolet, Inc.:** Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell that the license renewal “ought to pass” with any existing conditions and limitations; approved, 5-0; and **Lawless Inc.:** Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell that the license renewal “ought to pass” with any existing conditions and limitations; approved, 5-0.

Second Class Motor Vehicle Sales License renewals: Jeffrey Pollock dba Exclusive Automobiles: Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell to accept and make part of the permanent record a document from Mr. Pollock entitled “2019 Car Ledger Exclusive Automobiles;” approved, 5-0. Chairman Higgins asked Mr. Pollock where the two individual sales described on the ledger were made. Mr. Pollock replied both sales were made at auctions. Chairman Higgins asked if the vehicles were ever brought to Woburn. Mr. Pollock said they did not. Chairman Higgins said there are two sales to individuals listed on the ledger, but neither vehicle came to Woburn. Chairman Higgins asked Mr. Pollock to provide the same information about his sales to the committee next year. Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell that the license renewal “ought to pass” with the condition that Mr. Pollock must provide a sales ledger to the committee by November 2020;

approved, 5-0; **Nicolas Saba dba Montvale Service:** Alderman asked if this license renewal is paired with a special permit application that is currently before the council. Chairman Higgins responded that Mr. Saba's nephew with the same last name has the special permit application and this is a renewal. Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell that the license renewal "ought to pass," with any existing conditions or limitations; approved, 5-0; **Murray's Enterprises, Inc. dba Murray's Auto & Truck Sales:** Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell that the license "ought to pass" with any existing conditions or limitations; approved, 5-0; **Anchor Auto Sales, Inc.:** Motion made by Alderman Mercer-Bruen and seconded by Alderman Campbell that the license "ought to pass" with any existing conditions or limitations; approved, 5-0; **Ollie's Service Center:** Alderman Mercer-Bruen asked if there was anything in the folder that could delay renewal.
